Introducing March Capital

March Capital is a top-tier venture growth firm headquartered in Santa Monica, California and investing globally since 2014. March identifies entrepreneurs with a provocative vision to lead the future and later-stage companies poised for hyper-growth, then dares to go all in by leading rounds with deep conviction and concentration risk. With \$2B+ in capital over 4 funds and across 30 market-leading technology companies, March accelerates the digital transformation of Cloud-based software, automation, AI & IT Infrastructure.

The Venture Program with March Capital

The 3rd annual Venture Program with March Capital is designed to promote and support student interest in roles in entrepreneurship, innovation, and venture capital at the Claremont Colleges. The two-month program, conducted from October 20th to December 1st 2023, will expose students to the venture capital industry and innovation economy through guided research projects and a number of workshops led by the March Capital team.

During the program, students will investigate areas of interest to March Capital and present their findings in a pitch competition. March Capital will determine the focus areas for investigation prior to the program and students will group into 3 person teams to build investment theses around those areas. Historically, March Capital has spent time in the following areas: Fintech, Enterprise AI, Cybersecurity, eCommerce Enablement, and Data and Cloud Infrastructure.

This program is open to all SC students as long as they form a team with at least two RLCIE Fellows Candidates.

Prizes for the Fall 2023 Program may include a cash prize to the winning team of \$5000, a reception hosted by members of the March Capital Investment Team following the competition, invitations to attend The Montgomery Summit (March 5th and 6th 2024). All competitors who make it to the presentation phase of the program will receive March Capital swag.
