Fintech Incubator Program Application Summer 2022

The *Financial Economics Institute (FEI)* is excited to launch the 1st *Fintech Incubator* program this summer for students looking to do their own technology startup in the field of finance. The *Incubator* will be run through FEI's partnership with a world-renowned pre-Seed incubator in Silicon Valley.

Here are some details to keep in mind, as you consider joining this inaugural FEI program:

1. The program will be delivered in real-time over Zoom (i.e., virtual, but not recorded lectures)
2. Program starts: Wednesday, June 1st, 2022
3. Program ends: Wednesday, August 24th, 2022
4. *Tentative* Zoom meeting times: a 3-hour block on every Wednesday evening (5-8pm, tentatively)
5. The *Incubator* will be open to students from across all five Claremont Colleges ("5Cs").
6. Teams must be 2-3 students each, and can include a mix of students from different 5C colleges.
7. At least one member in each team must have technical / coding skills.
8. In order to participate in this Summer'22 offering, you must be planning to return back to school at the 5Cs for Fall'22 semester (i.e., open to all classes except seniors graduating this summer).

1. Answer all questions below, as directed – for each team member.
2. Include a resume – for each team member.
3. Provide an unofficial transcript – for each team member.

NOTE: all documents must be submitted as one pdf file in the order given above.

The teams that are selected will be invited to create a company page and personal profile on the incubator's website, before the program starts.
